Michelle is a member of CFA UK's Advisory Council and is helping to develop closer links between CFA UK and other professional bodies.

**Helena Morrissey** is chief executive officer of Newton Investment Management, a director of the UK's Investment Management Association (IMA) and is the founder of the '30% Club', a cross-business initiative to have 30% women on company boards by 2015. Through her work she has become an influential voice on the future of the fund management industry and the promotion of female talent.

**Russell Napier, ASIP,** is an author and a consultant with CLSA Asia-Pacific Markets and a director of The Scottish Investment Trust and Mid Wynd International Trust. He is the author of *Anatomy of the Bear: Lessons from Wall Street's Four Great Bottoms* and in 2004 established the course "A Practical History of Financial Markets" as part of the MBA Programme at Edinburgh Business School.

Anne Richards is chief investment officer at Aberdeen Asset Management and head of Aberdeen Solutions and the EMEA region. She began her career as a research fellow with the European Laboratory for Particle Physics (CERN) in Geneva, and held senior positions with JP Morgan Investment Management, Alliance Capital Limited, Cambridge Consultants Limited, Merrill Lynch Investment Managers, and Edinburgh Fund Managers before assuming her current position. Anne is also a member of CFA UK's Advisory Council and holds a number of non executive positions, including EveryChild, the University of Edinburgh, The Scottish chamber Orchestra and the Duchy of Lancaster.

**Richard Rothwell, ASIP,** is a former board member and chairman of CFA UK and currently chairs the society's Nominations Committee. A past winner of the Wincott Foundation Prize, he is the Managing Director and Founder of Stoneware Capital. A committed volunteer, Richard has been a member of various of the society's committees, chairing the IMC Panel, the examinations and education committee, and the finance committee.

**George Spentzos, CFA,** also a former CFA UK board member and chairman, is managing director in Global Markets at Societe Generale. In addition to holding various committee posts with CFA UK, George is also heavily involved with CFA Institute; as a writer and editor of exam questions since 2001, he has recently been appointed chair of the Council of Examiners (COE).

**Richard Taffler** is professor of Finance and Accounting and head of the Accounting, Markets and Organisations Group at Warwick Business School. An authority on behavioural finance, he has published over a hundred academic and professional papers and books and is a fellow of the Chartered Institute of Management Accountants.
